Oregon OSHA proposes to amend rules in Division 1, General Administrative Rules, to reflect the changes made in Senate Bill 556 passed into law by the 2007 Oregon Legislature. This action increases the time to file an appeal from 20 to 30 days and extends the period before civil penalty can be recorded as a judgment from 10 to 20 days after the final order. Also amended is the Extension of Correction Date – Application rule to allow greater discretion for granting extensions.
